<p>I, the undersigned official veterinarian inspector, hereby certify that:</p> <ol style="list-style-type: none"> The product has been manufactured in the EU (country origin:) according to the EU Regulation (EC) 178/2002 of the European Parliament and of the Council of 28 January 2002 laying down the general principles and requirements of food law. The product has been as manufactured and transported laid down with the principles, requirements and procedures covering all stages of food and feed production and distribution accordingly. The exported product and the product was moved from the manufactured Member States to the exporting Member States for trade into the Republic of Korea in full conformity with the import sanitation requirements according to the Special Act on Imported Food Safety Control of the Republic of Korea. There has been no reported outbreak of Newcastle disease within 10 km radius from the egg production farm for at least two months before export and no symptom of Newcastle disease within 60 days before export; There has been no outbreak of Salmonella symptom by <i>Salmonella enteritidis</i> or <i>Salmonella typhimurium</i> at the egg production farm or adjacent poultry farm for at last 90 days before export; The egg production farm is physically divided from the other facilities which raise and cage poultry and is be veterinary checked by the veterinarian authority of the exporting government at least within 60 days prior to export; The packages of the egg products are new and clean; The egg products have not come into contact with other grade egg, poultry and poultry product during the transportation from the exporting country to the Republic of Korea. The egg products were pasteurised to: Whole egg liquid at 64°C for min 150 sec, White egg at 55.6°C for min 870sec or at 56.7°C for min 232sec, Egg yolk at 62.2°C for min 138sec, Whole egg powder at 60°C for min 188sec, Dried albumin at 67°C for min 20 hours or at 54.4°C for min 513hours, Yolk powder at 63.5°C for min 3.5minutes. (Core temperature standard).
