The establishment is approved and supervised by the competent authority according to EU legislation. 2. The products described above are regarded as fit for human consumption and may be placed on the EU market without restrictions. 3. The products have been handled, produced and packed under hygienic conditions according to EU legislation. 4. The products described above comply with the relevant EU legislations regarding substances (pesticides, contaminants and veterinary drugs). 5. The raw materials (milk) from which the products are produced were obtained from animals that were in a good general state of health. 6. The milk from which the products are produced, were derived from animals in which Bovine Spongiform Encephalopathy (BSE) was not officially identified at the time of collection. 7. The EU has implemented limits for harmful radioactive contamination and official surveillance programs on food-stuffs, here among milk and milk used for the processing of dairy products, for content of isotopes and on the general situation concerning radioactive fall-out in EU. Based on national surveillance programs the products manufactured by the producer are considered safe and fit for human consumption. 8. Animal products from EU are subjected to a surveillance program for dioxins and PCBs in accordance with Council Directive 92/23. Regulation (EC) no. 1881/2006 sets maximum residue limits for dioxin, PCB etc. In accordance with the EU legislation, products that are found non-compliant with the EU maximum levels cannot be placed on the market. All products produced in the EU containing raw materials of animal origin are regarded as safe and fit for human consumption. 9. <i>Delete a or b, as appropriate.</i> <ol style="list-style-type: none"> a.
