Subject: Regulations for the Import of dairy products and Composite foods to Israel

In order to obtain an import license for the importation of dairy products or Composite food to Israel, the producer/supplier has to apply for such a license to the Food Control Service of the Ministry of Health through an Israeli importer, prior to shipment of the food items. The local importer would then have to submit the necessary documents showing that the

products to be imported comply with the regulations laid down in the official Israeli

Standards as well as complying with the Mandatory Regulations regarding.

Dairy Milk Products:

- A. List of ingredients including food additives, identified by their chemical name
- B.- Product label. (original)
- C. -Certificate of analysis, including chemical phosphatase test and microbiological.
- D. -Declaration or analysis certificate regarding inhibitors, drug residues, antibiotics and pesticides residues.
- F. -Certificate from the veterinary authorities
- G. -Flow diagram of production, including technological process.

Canned Milk Products:

- A. List of ingredients including food additives, identified by their chemical name or respective E-number.
- B.- Product label. (original)
- C. -Certificate of analysis, including chemical phosphatase test and microbiological.
- D. -Declaration or analysis certificate regarding inhibitors, drug residues, antibiotics and pesticides residues.
- F. -Certificate from the veterinary authorities, according to EEC.
- G. -Flow diagram of production, including technological process
